4.2. Most important symptoms and effects, both acute and delayed

- Symptoms/injuries : Not expected to present a significant hazard under anticipated conditions of normal use. This product contains beneficial microorganisms. Monsanto exclusively uses non-pathogenic beneficial microorganisms that are considered to be non-allergenic, non-irritating and non-sensitizing when used as directed. Exposure to very high levels of airborne microbial spores may result in very rare respiratory impairments or cause an allergic reaction in sensitized individuals.

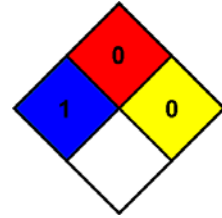
